This agreement consists of the following 7 conditions.

- 1- 1-The owners of "male cat" and "female cat" accept in advance that their cat has no health problems and that their vaccine is complete. The "guest cat" is delivered by the owner to the House of the "host cat". "Guest cat" during the time he is a guest, his health and basic needs are met by the host. In any emergency, the parties must notify each other within 15 minutes. After mating takes place, the "host" has to hand over the guest cat to the owner of the "guest cat". "Guest cat" owner gets his cat to come and deliver.
- 2- 4 weeks after mating, the "male cat owner" conducts an ultrasound check at the "female cat" veterinary clinic and receives written results.
- 3- The female cat owner covers all costs before, at the moment of birth and after birth, except for "ultrasound"
- 4- Determination of kittens sharing 5 after birth. Weeks are done. Cat owners can't reserve and own any kitten until their kittens are identified for sharing.
- 5- Kittens sharing is as follows.
  - a. 1 in a healthy kitty, the kitten belongs to the female owner.
  - b. 2 healthy kitty, 1 female owner, 1 male owner is given. The right to choose belongs to the female owner.
  - c. 3 healthy kitty, 2 female owners, 1 male owner is given. The right to choose belongs to the male owner.
  - d. 4 healthy kitty, 3 female owners, 1 male owner is given. The right to choose belongs to the male owner.
  - e. 5 healthy kitty, 3 female owners, 2 male owners are given. 1 male and 1 female owner has the right to choose.
  - f. 6 healthy kitty, 4 female owners, 2 male owners are given. 1 male and 1 female owner has the right to choose.
  - g. In 7 healthy kitty, 5 are given to the female owner and 2 to the male owner. 1 male and 1 female owner has the right to choose.
  - h. In 8 healthy kitty, 5 are given to the female owner and 3 to the male owner. The right to choose belongs to the male owner.
- 6- After the kittens are separated from breast milk (8-12 weeks), but the cat can be taken for paternity. Before this time, the "male cat owner" cannot request kittens. 1 time a week and in accordance with prior notice "male cat owner" has the right to see kittens. 5 and above kittens "male cat owner" makes food support.
- 7- in case of failure to comply with the Articles of the contract, the party that does not comply with the contract has the right to sue the other party by the courts of the country and province to which it is affiliated.

We undertake that we have read, understood and accepted this 7-article agreement. We accept and undertake in advance that we will comply with the 7 articles mentioned above. Otherwise 7. We accept that we are subject to the penalty condition set out in the article.
